Parking and entrance are in the rear of the brown CrossFit building.

Socks and a waiver are required. Online waivers are preferred.

Jump Nation Participation Agreement, Release and Liability Waiver

In consideration for being allowed to enter the facility, spectate and/or participate in activities at Jump Nation, LLC dba Jump Nation, the undersigned, on his or her behalf, and on the behalf of the Participant(s) identified and any accompanying minor(s) not listed, acknowledges, appreciates, and agrees as follows:
1. Representation: I represent that I am the parent or legal guardian of the Participant(s) named and any accompanying minor(s) not listed, or I have obtained permission from the parent or legal guardian of the Participant(s) named and any accompanying minor(s) not listed to execute this Agreement on their behalf. In the event that I do not have the requisite authority to sign this Agreement on behalf of the Participant(s) named or any accompanying minor(s) not listed, I agree that I shall be solely liable for any and all actions, cause of actions, penalties, claims, costs, services, compensation or the like resulting from this misrepresentation. Participant(s) may be named on the front or back of this Agreement.

2. Assumption of Risks: I acknowledge and understand on behalf of myself and the Participant(s) and any accompanying minor(s) not listed, that there are known and unknown risks associated with participation in or spectating of Jump Nation activities and the use of inflatable and any other facility equipment that could result in physical or emotional injury including, but not limited to: contusions, fractures, scrapes, cuts, bumps, paralysis, exposure to viruses (COVID-19), pathogens, death, or other bodily injury or property damage. I, for myself and the Participant(s) named and any accompanying minor(s) not listed, willingly assume the risks associated with spectatorship and/or participation and accept that there are also risks that may arise due to other participants, patrons, or staff, which I also willingly assume.

3. Agreement to Follow Rules/Instructions: I agree that the Participant(s) named and any accompanying minor(s) not listed, and I shall comply with all rules, posted safety signs and verbal instructions as condition for spectatorship and/or participation in any activity at Jump Nation.
4. Release of Liability: I, for myself, the Participant(s) named, and any accompanying minor(s) not listed, and our respective heirs, assigns, representatives, and next of kin agree to release and hold harmless Jump Nation, Jump Nation LLC, its owners, their predecessors, parent, subsidiaries and affiliates, officers, employees and contractors, and their heirs, successors and assigns, from any and all liabilities, causes of action, claims, demands, injuries, or damages that may arise from spectatorship and/or participation, except for those arising from the gross negligence or willful misconduct of Jump Nation.

5. Indemnification and Defense: I additionally agree to indemnify Jump Nation, Jump Nation, LLC, its owners, officers, their predecessors, parent, subsidiaries and affiliates, officers and employees for any defense costs or expenses arising from any and all liabilities, causes of action, claims, demands, injuries, or damages arising from spectatorship and/or participation, except for those arising from the gross negligence or willful misconduct of Jump Nation.

6. Medical Care/Coverage: If either the Participant(s), any accompanying minor(s) not listed, or I am injured or become ill, I acknowledge that medical assistance may be required, which I acknowledge will be at my own expense or at the expense of my personal insurer(s). I represent and affirm that the Participant(s), any accompanying minor(s) not listed, and I have adequate and appropriate medical insurance. I understand and agree that Jump Nation will not pay for any cost or expenses incurred should the Participant(s), any accompanying minor(s) not listed, or I be injured unless such injury was caused by the gross negligence or willful misconduct of Jump Nation. I certify that the Participant(s), any accompanying minor(s) not listed, and I am physically able to spectate and/or participate in all activities at the facility without aid or assistance. I further certify that I am willing to assume the risk of any medical or physical condition that the Participant(s), any accompanying minor(s) not listed, or I may have. I understand that Jump Nation assumes no responsibility for providing medical care.

7. Arbitration: If there are any disputes regarding this Agreement, I on behalf of myself and/or the Participant(s), any accompanying minor(s) not listed, hereby waive any right I and/or the Participant(s) and/or any accompanying minor(s) not listed, may have to a trial and agree that such disputes shall be brought within one year of the date of this Agreement and will be determined by binding arbitration before a single arbitrator. I further agree that the arbitration will take place at a location within 25 miles of Shrewsbury, Massachusetts, and in accordance with the rules of the American Arbitration Association then in effect, and that the substantive law of Massachusetts shall apply.

8. Enforceability: I agree that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I hereby acknowledge that I have had sufficient opportunity to carefully read the entire Agreement. I am aware that this is a release of liability and a contract between Jump Nation LLC dba Jump Nation and me in which I make knowing and voluntary waivers and releases of related legal rights for myself, the Participant(s), and any accompanying minor(s) not listed. I am legally competent to understand and complete this Agreement. I hereby execute this Agreement without coercion as written without alteration and sign it of my own free will below.
